

## Instructions

Thank you for your interest in this Sourcewell program. We want to make this process as easy and seamless as possible, so we have a few recommendations before you begin.

Download a copy of the document and open it in Adobe Acrobat Reader. This is standard software on most machines; however, if you don't already have this installed on your computer, you can obtain it for free at https://get.adobe.com/reader/.

This is <u>very important</u> because if you don't use Adobe Reader, but instead complete the document using an internet browser (Internet Explorer, Firefox, Chrome, etc.), you won't be able to save your work, digitally sign the form, or submit electronically.

- Once you have opened the document in Acrobat Reader, immediately 'Save As' from the 'File' menu on the upper left-hand corner. Save often as you work through the document.
- Review your document to ensure everything has been completed. When ready, submit to the Sourcewell contact as indicated.

# **EMS Training Reimbursement**

#### 2023-2024

EMS Training Reimbursement funds are awarded on a first-come, first-served basis while funds exist and are intended to support completed training approved by the Emergency Medical Services Regulatory Board (EMSRB). Approved trainings include initial and refresher courses on CPR/AED, Basic First Aid, EMR, and EMT.

#### Reimbursement limits

- \$3,000 per entity per year for law enforcement, municipal ambulance, and first response teams.
- \$1,000 per entity per year for dispatchers, social workers, public health, public works, highway departments, and nonprofits that have fewer than 20 FTEs and provide direct services to clients that are victims of crime or children.

### Eligibility requirements

- The applicant organization must:
  - Be a Sourcewell participating agency. Register at sourcewell-mn.gov/register
  - Be a city, county, other government association, 501(c)(3) nonprofit, or first response team located in Cass, Crow Wing, Morrison, Todd, or Wadena county.
  - Reimbursement requests must be received in the same fiscal year that the invoice for service is received (July 1-June 15).
- Reimbursement requests must not be for individuals who are also firefighters.
- A reimbursement request must include:
  - A completed reimbursement request form
  - Invoice for training provided
  - Training sign-in sheet

#### Reimbursement process

**Step 1:** Sourcewell staff will review each reimbursement request to ensure the criteria outlined above have been met. Requests that do not meet the criteria will not be eligible for reimbursement funds.

**Step 2:** Entities that pass the initial review process will be awarded funds on a first-come, first-served basis while funds remain available.
